#### Pursuant to:

The Board of Directors (BoD) of Traphaco Joint Stock Company would like to submit to the General Assembly of Shareholders for consideration and approval the following issues:

### 1. Dismissal of BoD member

Dismiss from the position of member of the Board of Directors for the term 2021-2025 for Mr. Nguyen Anh Tuan from the end of the Annual General Meeting of Shareholders on April 14, 2023.

Reasons: On April 10, 2023, Mr. Nguyen Anh Tuan submitted his resignation letter from the position of BoD member to the Board of Directors of Traphaco Joint Stock Company (resignation letter attached).

## 2. Additional election of 01 BoD member
